

PRE-PURCHASE SURVEY / GEMİ KONDÜSYON SÖRVEYİ HİZMETLERİ

We provide thorough vessel inspection. Vessel's hull, machinery, rig, service systems and equipment are examined by competent surveyors in order to report conditions found. Findings are recorded in a clear and detailed report along with detailed recommendations.

These surveys should include, where possible, inspection of hull out of water, structural integrity and water-tightness of the hull, rudder and steering gear. This will also include the condition of the cathodic protection, and an examination of the machinery, electrical, propulsion, fuel, sewage and other on-board systems. A sea trial may be conducted, where practical too. The nautical items, cosmetic appearance, and an assessment of the overall level of maintenance will be evaluated. The mast and rigging, when stepped, shall be inspected to the 'head height' only. The Survey does not provide an opinion on the condition of those parts of the vessel which are covered, unexposed or inaccessible nor the areas or spaces not presented / visible; for example behind linings, beneath fixed cabin soles or floors etc.

A typical Pre-Purchase Condition Survey Report is based on the day the vessel was inspected **not** the day the report was written or issued. Inspection will probably take not less than one day.

<u>VALUATIONS, FİNANCE AND INSURANCE SURVEYS</u> / GEMİ DEĞERLEME VE SİGORTA SÖRVEYİ HİZMETLERİ

These inspections are performed so that the insurance and/or finance institution can determine the fair market value or whether or not the vessel is an acceptable risk. The structural integrity and safety for its intended use are examined and reported.

Any estimates of value given will be determined by studying the average current market value of similar vessels and adjusting this figure to reflect the condition of the vessel at the time of survey.

DAMAGE SURVEYS / GEMİ HASAR TESPİT SÖRVEY HİZMETLERİ

Damage surveys are occasional surveys which are, in general, outside the program of periodical surveys and are requested as a result of the vessels damage or other defects. The damage might result from grounding, collision, heavy weather, contact, fire, machinery or cargo gear breakdown and other damages or defects. In this case ENGiN DENiZ will provide detailed damage assessment, repair supervision, approval of repair specifications and review of repair invoices.

Accident Investigation

Bunker Survey

Cargo Surveys

Pre-loading Survey

Performing condition surveys of cargo holds and hatch covers on behalf of shippers, receivers, cargo owners and underwriters. Issuance of Certificate of Readiness for loading.

Pre-PSC Inspection
